13. Update on IMLS Funding (Information)

Meyer shared articles from MCFLS on the status of IMLS funding and its impact on states if cut.

14. Trustee Bylaws Review (Information/Action)

Three-year review of trustee bylaws. Edits were suggested and will be brought back at May meeting.

15. Wisconsin Policy Forum Study (Information)

City Administrator Brever spoke about the Common Council meeting and presentation by the Wisconsin Policy Forum. The Council approved the creation of a committee that will examine the options further. Trustees Maass and DeMont will serve as the Library Board representatives to the committee.

16. Square & Vending Prices (Information/Action)

Meyer shared suggested change in prices for vending to better accommodate the Square fees. Trustees agreed to change the price on drinks to \$1.50 and to keep snack prices the same.

Meyer shared that staff frequently receive requests from the public to purchase items like folders, envelopes, and stamps. Trustees shared their support in starting this small fundraiser with envelopes and folders.

Meyer shared an update on the behavior concerns that have arisen in regards to the children's room play area.
